I am delighted to welcome you to the third edition of the Ireland INC Index. Working with our partners KPMG, this year's Index highlights the fastest growing Irish companies in the United States and truly illustrates the strength and depth of Irish business across all 50 States.

While the seismic impact of US investment in Ireland is well-articulated, the true symbiosis in the economic relationship between our two countries can be often overlooked. It is an untold tale, with almost as many people employed in the US by Irish-owned companies as there are people employed in Ireland by US companies.

I am reminded of Warren Buffet's words: "Someone's sitting in the shade today because someone planted a tree a long time ago." Through incremental steps and small roots, Ireland's footprint in the US has continued to progress in line with the successes of our best indigenous companies. The Ireland INC Index, in association with our partners KPMG, and working with Irish and US state agencies, aims to address this. In 2019, Ireland INC led a delegation of Irish CEOs to Capitol Hill for meetings with Members of Congress and the current administration including Speaker Pelosi, Chairman Neal, and Secretary Wilbur Ross. The latest figures from SelectUSA and the US Department of Commerce, released in February, put Ireland as the ninth largest source of FDI in the United States, a truly remarkable feat for a nation of our size. Ireland INC has been continuing to engage with US government and public sector stakeholders to advance the message of Ireland INC and the companies in this index. Ireland remains the only country to host a day at the New York Stock Exchange, with Ireland Day celebrating its tenth instalment in 2020.

Ireland and the United States have been challenged once again by a volatile political climate. With the departure of the United Kingdom from the European Union on January 21st this year, many questions remain unanswered regarding future trade relations between Ireland and the UK, the US and the UK, and indeed between our countries and the European Union. However, one certainty remains: The relationship Ireland has with the United States, one that has existed for centuries, remains as unshakeable as ever.

I look forward to working with our partners KPMG, our friends in the Irish and US governments and Irish business to continue building this Index providing a vital source of information and guidance to the wider market. IRISH-US ECONOMIC RELATIONSHIP

SEAN DAVIS Regional Director North America, Enterprise Ireland



Ireland has really transformed itself within the last 30 years. What we are bringing to the market is true innovation. When it comes to commodity-type products, businesses need to solve a problem, create new opportunities and create value. That's what I think Irish companies bring to the market, and that's what American companies recognise in them.

Among the dynamic Irish companies that have a significant presence in the US are Kerry Group, employing over 1,000 in their headquarters in Beloit, Wisconsin and over 6,000 people across the country, and Icon Clinical, one of the largest clinical research organisations in the world. Glanbia, Kingspan, Mergon and Modular Automation are all employing in locations across the US, many of which are in highvalue positions. What makes these, and many more, Irish companies so successful is that they're not just looking to sell, they are coming to invest and partner with American businesses across all 50 states.

There are, of course challenges, the most obvious one being that there is most definitely a different business culture in the US. Another consideration is the economic and geographic size of the country. Consider that the State of California's economy is approximately the size of the UK. So, as a business, trying to cover coast-to-coast and border-to-border is enormously challenging. I would advise any Irish company to pick an area that is geocentric to a reasonably large number of customers, that way you are optimizing the resources you have available. It is vital to have a robust and focussed business plan. Of course, the very nature of business development requires flexibility, nonetheless it is important that your plan minimizes the gap between commercial aspirations and realities.

Despite the turbulence from trade tensions, the UK exit from the EU and debates over corporation and digital taxes, the economic relationship between Ireland and the US is a two-way story. Irish companies employ almost as many people in the US as US companies employ in Ireland. Over 500 Irish companies operate in the US in sectors as diverse as agrifood manufacturing, building materials, construction and services. These firms bring investment, good quality jobs and wages to the US. A new chapter is now being written by a generation of young entrepreneurs from Ireland who have begun in recent years to set up new businesses in the US, emphasising the mobile nature of talent between the two countries and cultural compatibility.



IRISH INVESTMENT IN THE US FACTS AND FIGURES

As more and more Irish companies successfully invest in the US, the opportunities for Irish and American businesses to collaborate and develop strong partnerships are abundant according to Enterprise Ireland.

Ireland is the ninth largest source of foreign direct investment (FDI) to the United States. Over 900 Irish companies are exporting to the US and there are currently 600 Irish companies in over 1,000 locations in the States, employing over 106,000 people. According to the US Bureau of Economic Analysis, Ireland's FDI into the US stands at \$235.7 billion. This is a very significant milestone, especially for a country that is economically one sixtieth the size of the US. We have many decades of an active trade relationship and excellent air connectivity with the United States; this presents a very vibrant market and partnering opportunity for many Irish companies.

The scale of the growth opportunity for Ireland and the US is incredible. This is a \$22 trillion economy, staggering in scale. The US is a very innovative, competitive, and forwardthinking economy. With new direct flights between the US and Ireland being added every year, it is a market that is accessible. Across almost every sector there is a business and partnering opportunity for Irish companies that are willing to invest the time and resources, and that is going to stretch well into the future. The Enterprise Ireland US team are based in New York, Boston, Austin, Chicago, San Francisco and Seattle, working directly with hundreds of our client companies to help deliver real value on both sides of the Atlantic in what has been, and will continue to be, a mutually beneficial trading relationship.

Founded in 2010, Ardmore Shipping owns and operates a fleet of mid-size product and chemical tankers, providing worldwide seaborne transportation of petroleum and chemical products. The Company listed on the NYSE in August 2013 and has offices in Cork, Bermuda, Singapore, Houston and Hong-Kong. Ardmore has a fully "eco"

fleet and has been at the forefront of environmental and social progress for many years and it is the top ranked product tanker company of all US public shipping companies for corporate governance. Ardmore celebrates its 10-year anniversary this year.

Co-founded by Limerick man CEO Barry Lunn and CTO Mike Gleaves, Arralis develops satellite communications and radar technology and works with high profile clients including the European Space Agency. Founded in 2013, Arralis is headquartered at the University of Limerick campus with a design centre in Belfast and has offices in Swindon and Florida with a business development and sales team based in the UK.

ASAVIE

IoT firm Asavie Technologies' platform powers on-demand services for the secure and intelligent distribution of data to connected devices for clients such as AT&T, Eir, Three, Telefonica and Vodafone. Founded by Ralph Shaw in 2004 with the vision of simplifying how enterprises can harness the power of mobile devices and the Internet of Things, the company is headquartered in Dublin with offices in the UK, North America, Spain and Malaysia. They work with over 10,000 customers.

ASYSTEC

Established in 2011, Asytec is an awardwinning Data Management Solution Provider with customers in Ireland, the UK and North America. The company has three Irish offices located in Dublin, Limerick and Cork and a US office in Minnesota. They aim to guide customers through every stage of their data management queries through to the implementation process.

ATLANTIA FOOD CLINICAL TRIALS LTD

A full service contract research organisation (CRO) delivering end-toend solutions for the functional food, beverages, ingredients and supplements markets. AUTOENTRY

Founded in early 2016 by software developer Brendan Woods, AutoEntry automates manual data entry. The software utilises Artificial Intelligence (AI) and Optical Character Recognition (OCR) and every aspect of the software was designed to meet the needs of its users. As well as its HQ in Dublin, AutoEntry has offices in the UK, Melbourne and Arizona.

AVECTAS

Avectas is an Irish life science technology business headquartered in Dublin and with US offices in Cambridge, Massachusetts. Avectas has developed a patented electrospinning and electrospraying technology platform, Spraybase, built on eight years of R&D funded by the Irish Government and EU grants.

AVAIL

Avail is a B2B SaaS platform created to promote independence for children and adults with cognitive disabilities. The platform is mobile technology based and uses videos, pictures, audio and text prompts to help users master a wide range of routine tasks and life skills. The platform is being used by organisations in Ireland, the UK, and North America.

AVVIO

Founded in 2002, Avvio has been a pioneer in hotel and accommodation booking platforms. In 2017, the company launched the first booking engine powered by Al continuing to help hundreds of hotels, hotel groups, and serviced apartment operators increase their direct bookings. Avvio is headquartered in Limerick, Ireland with offices in Dublin, London, and New York.

AXONISTA

Axonista is an interactive video technology company which enables video streaming services for media companies that have two-way audience interaction. Viewers can shop, sign up to newsletters, or learn more about what they're watching, all while they are watching the video. Customers include QVC, Virgin Media, and Sinclair Broadcast Group. Apps powered by Axonista's technology have been delivered to over 500k users and have won 11 awards. Axonista has offices in Dublin and New York, and was founded in 2010, by Claire McHugh and Daragh Ward.

Maryland is providing \$1 million in funding for the project. BHSL, which is providing the remaining \in 2 million in funding for the new project, was established by brothers Jack and Declan O'Connor in 2009. It employs 28 people at its headquarters in Ballagh.

BIG RED BARN

Mayo company Big Red Barn began life providing a sturdier alternative to marquees for events, before moving into modular homes solutions. In 2018 Big Red Barn entered into a public private partnership with the City of Warwick Housing Authority which will fund a pilot building on a site in Warwick, Rhode Island, supplying a modular home for a low income family, to demonstrate the ability to provide costeffective housing for the city.

BIMEDA

A global leader in animal health, Bimeda has established markets in more than 70 countries worldwide and has R&D, manufacturing and distribution capabilities across Europe, North America, South America, Africa, Asia and Australia. Bimeda employs almost 800 employees worldwide with its US headquarters based in Oakbrook Terrace, IL. The Bimeda US product portfolio focuses on five key categories: ecto- and endo-parasiticides, water soluble antimicrobial, injectables and nutritional products.

BIO-MEDICAL RESEARCH

Bio-Medical Research has been creating EMS (Electrical Muscle Stimulation) technology for over 50 years. Galway is home to Bio-Medical Research, with offices and employees located in the US, France, Hong Kong, UK and Singapore.

BLUEFACE

Blueface, a Comcast Business company, is a leading provider of Unified Communications as a Service (UCaaS). Blueface enables service providers with a suite of cloud communications technologies and is listed on the UCaaS Gartner Magic Quadrant. In January 2020, Blueface was acquired by Comcast with a significant investment made to scale the technology and engineering teams in Ireland. Comcast Corporation (Nasdaq: CMCSA) is a global media and technology company with three primary businesses: Comcast Cable, NBCUniversal, and Sky.

Brightwork Inc. formerly known as Aimware, Inc. is a project management company specialising in Microsoft SharePoint platform solutions. These solutions make project and portfolio management simpler and more profitable for Brightwork customers. The company was founded in 1995 by Eamonn McGuinness and has offices in Europe and the United States.

BSM IRELAND LTD/BSM INTERNATIONAL

BSM is a management consulting firm known for providing Real Lean transformation services to life science companies. The company specialises in the implementation of Real Lean techniques specifically Levelling, Flow and Standard Work. BSM operates from Galway, Ireland and Georgia, USA.
